# **Extension of Overnight On-Street Permit Parking Hours - Queensdale Avenue**

### **SUMMARY**

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend overnight on-street permit parking hours on Queensdale Avenue, between Coxwell Avenue to Monarch Park Avenue, from 11:00 p.m. to 5:00 a.m., 7 days a week, to 11:00 p.m. to 10:00 a.m., 7 days a week.

By extending overnight on-street permit parking hours, the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking through their tagging and towing operations.

#### RECOMMENDATIONS

## Transportation Services recommends that Toronto and East York Community Council:

1. approve the extension of overnight on-street permit parking hours of operation on Queensdale Avenue, between Coxwell Avenue to Monarch Park Avenue, from 11:00 p.m. to 5:00 a.m., 7 days a week, to 11:00 p.m. to 10:00 a.m., 7 days a week.

#### **ISSUE BACKGROUND**

A request was received from Councillor Case Ootes, on behalf of area residents, for the extension of overnight on-street permit parking hours on Queensdale Avenue, between Coxwell Avenue to Monarch Park Avenue, from 11:00 p.m. to 5:00 a.m., 7 days a week, to 11:00 p.m. to 10:00 a.m., 7 days a week.

#### COMMENTS

Queensdale Avenue, between Coxwell Avenue and Monarch Park Avenue, is a local street operating two-way east/westbound, on a pavement width of 8.5 metres. No TTC service operates on Queensdale Avenue. Currently parking operates on an alternate side basis. Parking is allowed for a maximum period of 3 hours with overnight on-street permit parking in effect from 11:00 p.m. to 5:00 a.m., 7 days a week.

Area residents requested the extension of overnight on-street permit parking hours on Queensdale Avenue, between Coxwell Avenue and Monarch Park Avenue, to alleviate the problem of long term parking.
