PURPOSE OF THE APPLICATION:

To permit the semi-detached dwelling to be maintained on a reduced size lot.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 6(3) Part II 4, Zoning By-law No. 438-86

The by-law requires a building to have a minimum rear yard setback of 7.5 m. The proposed rear yard setback is 0.90 m.

2. Section 6(3) Part VII 1(II), Zoning By-law No. 438-86

The by-law requires a lot to have minimum lot frontage of 6.0 m.

The proposed lot frontage is 5.64 m.

3. Section 4(4)(B), Zoning By-law No. 438-86

The by-law requires a minimum of 1 parking space to be provided.

The proposed number of parking spaces is 0.

The Committee will consider, jointly, Applications B0091/08TEY and A660/08TEY
