Subject: Demolition and Replacement with Two Structures within the Wychwood Park

Heritage Conservation District – 106 Wychwood Park

Recommendations:

The Toronto Preservation Board, after further consideration of the revised proposal, recommended to City Council, at its meeting on April 6, 2009, that:

- 1. City Council reject issuance of the demolition permit pursuant to the Ontario Heritage Act for the property at 106 Wychwood Park.
- 2. City Council approve the alterations to the property at 106 Wychwood Park pursuant to the Ontario Heritage Act substantially as set forth in the application to alter dated and received by the City on March 27, 2009, subject to such conditions as the Chief Planner and Executive Director, City Planning, may report on to the April 6, 2009 City Council meeting.

Background:
