## SUMMARY

This staff report is in response to an application for a Fence Exemption to maintain an existing 2.44 metres high close board wooden fence with a lattice top, and a 2.55 metres high wooden gate with an arbour, at the rear yard on the south side of the property, for which the Etobicoke York Community Council has delegated authority from City Council to make a final decision.

## RECOMMENDATIONS

## Municipal Licensing and Standards recommend that:

1. The Etobicoke York Community Council refuse the application, as the proposed fence does not comply with the provisions of Toronto Municipal Code Chapter 447, Fences.

## Financial Impact

There are no financial implications resulting from adoption of this report.

## ISSUE BACKGROUND

This is a two-storey detached house located in between 77 and 81 of Thirty Eighth Street (Attachment 1). In October 2008, Municipal Licensing and Standards received a complaint that the fence erected at the rear of 79 Thirty Eighth Street was too high.

An inspection of the property on October 23, 2008 revealed that the rear yard of the property, which is fenced, is accessible via a wooden gate with an arbour on the south side of the house. The height of the gate measured to the top of the arbour is 2.55 metres (Attachments 2, 3 and 4).

The fence enclosing the rear yard of the property is predominantly 1.80 metres high of close board wooden construction except on the south side (adjacent to 77 Thirty Eighth Street), lattice panels of 640 millimetres height have been added on top which makes a total height of 2.44 metres over a length of 9.11 metres (Attachments 2 and 3). Also, there is a short section of chain link fence, on the north side adjacent to 81 Thirty Eighth Street which measures 1.20 metres high (Attachment 4).

## COMMENTS

Chapter 447 of Toronto Municipal Code, Fences, restricts fences at the rear yard of a single residential property to a height of 2.0 metres. A fence is defined in the By-law as a barrier that wholly or partially screens from view, encloses or divides a yard, and the fence height is measured at any point along its length from grade.

As the section of the close board wooden fence with a lattice top, measuring 2.44 metres in height, and the wooden gate with an arbour, measuring 2.55 metres in height, have exceeded the 2.0 metres height restriction prescribed under the Fence By-law, a Notice of Violation has been issued to the Property Owner, requiring him to bring the fence in conformity with the By-law requirements.
