SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval for the installation of a "No Parking Anytime" regulation on the south side of Meadowvale Drive between Thompson Avenue and the west limit of the road, east of Mimico Creek.

This proposed parking regulation amendment will address vehicular access issues on this street.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

- 1. Rescinding the "No Parking Anytime" regulation on the south side of Meadowvale Drive between Prince Edward Drive and Thompson Avenue.
- 2. Enacting a "No Parking Anytime" regulation on the south side of Meadowvale Drive between Prince Edward Drive and the west limit of the road, east of Mimico Creek.

ISSUE BACKGROUND

Transportation Services staff received a petition from area residents requesting to have parking prohibited on the south side of Meadowvale Drive between Thompson Avenue and the west limit of the road, east of Mimico Creek. The request is the result of vehicles being parked on both sides of this relatively narrow section of Meadowvale Drive, reducing the travel portion of the road. Maps of the area are Attachments 1 and 2.

COMMENTS

Meadowvale Drive, between Thompson Avenue and the west limit of the road, east of Mimico Creek, is a 7.2 metre wide, two-way local road. The road is built to rural standards (i.e. no curb and gutter) and there are no sidewalks on ether side of this portion of road.

Parking is currently allowed, subject to the City-wide three-hour parking limit, on both sides of Meadowvale Drive, west of Thompson Avenue; however, parking is prohibited on both sides of the road to the east of Thompson Avenue, up to Royal York Road on the north side and up to Prince Edward Drive on the south side.

Based on the signed petition representing all six properties abutting Meadowvale Drive between Thompson Avenue and the west limit of the road, east of Mimico Creek, staff recommends extending the existing "No Parking Anytime" regulation on the south side of Meadowvale Drive, to include this portion of road.
