PROPOSAL

The applications propose to amend the Official Plan and former City of Etobicoke Zoning Code to permit a building primarily to be used for a senior citizens retirement residence. The building will be seven storeys in height, where 6 floors will contain 86 rooms and library and dining facilities, and the 7th floor is for roof top amenity uses. The 86 rooms will be rented to senior citizens. Three rental apartment units are also proposed in the building. The applications propose to demolish the existing 3-storey, 10-unit rental apartment building on the site. Public Benefits under Section 37 of the Planning Act will also be provided.

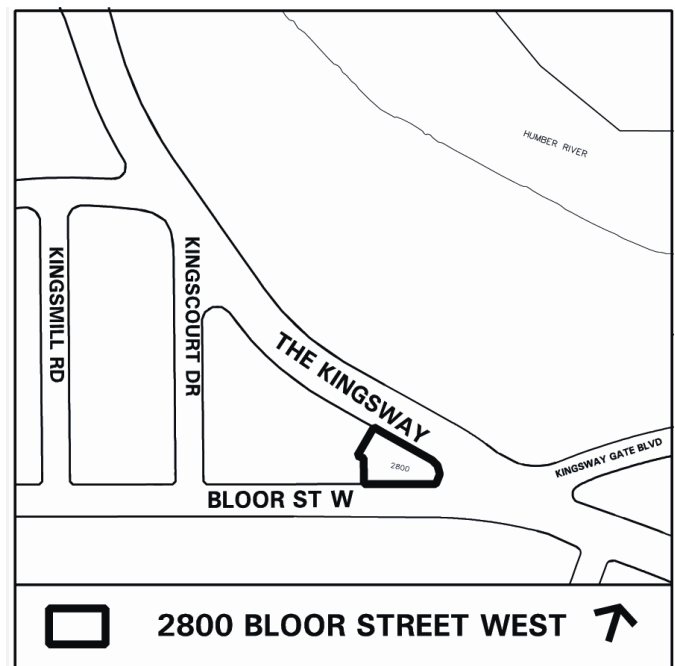
FURTHER INFORMATION

If you wish to be notified of the adoption or refusal of the proposed Official Plan Amendment and/or passing of the Zoning By-law Amendment you must make a written request to the City Clerk, attention: Glenda Jagai, Administrator, Etobicoke York Community Council, at the address set out in this notice or by Fax: (416) 394-5600.

Official Plan and Zoning By-law Amendments Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Glenda Jagai, Administrator, Etobicoke York Community Council, at the address set out in this notice or by Fax: (416) 394-5600 before the proposed Official Plan Amendment is adopted or refused or Zoning By-law Amendment is passed or refused the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
