PROPOSAL

The application proposes to demolish a 10-unit rental apartment building at 2800 Bloor Street West. The owner is proposing to replace 3 rental housing units in this redevelopment. The 3 replacement units will be targeted towards seniors, therefore existing tenants will not have the right to return to the replacement rental housing. The owner will be providing assistance with the relocation to the tenants.

A Rental Housing Demolition and Conversion application (08 103657 WET 00 RH) under Section 111 of the City of Toronto Act (Chapter 667 of the Municipal Code) has been made to permit the demolition. Under the *City of Toronto Act*, the demolition of a rental property with six or more dwelling units is prohibited without a permit obtained from the City. Related applications to amend the Official Plan (09 137818 WET 05 OZ) and the Zoning Code (07 246603 WET 05 OZ) under the *Planning Act* has also been made and will be considered at the same time.
