The application to amend the Zoning By-law proposes to permit a 52,000 square metre commercial development, which includes a large retail store and a combination of small and mid-size retail, office and service shops at 30 Weston Road and part of 33 Gunns Road. Public benefits under Section 37 of the Planning Act will be provided.

This land is also subject to an application under the Planning Act for Site Plan Approval, Application No. 08 226555 WET 11 SA.

Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Glenda Jagai, Administrator, Etobicoke York Community Council, at the address set out in this notice or by Fax: (416) 394-5600 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
