# **FOOD FOR THOUGHT** (February 5, 2009) & alPHa BUSINESS MEETINGS (February 6, 2009)

**Day One** of the 2009 alPHa Winter Semi-Annual Meeting features a full day program, *Food for Thought*, on public health perspectives regarding food production and sustainability as well as food and beverage marketing to children. ## food for thought speakers

#### MORNING KEYNOTE: Dr. Robert Lawrence

Robert Lawrence is the Center for a Livable Future Professor and Professor of Environmental Health Sciences, Health Policy, and International Health at the Johns Hopkins Bloomberg School of Public Health and Professor of Medicine at the Johns Hopkins School of Medicine. Dr. Lawrence is a graduate of Harvard College and Harvard Medical School, and trained in internal medicine at the Massachusetts General Hospital in Boston, Massachusetts. He served for three years as an epidemic intelligence service officer at the Centers for Disease Control and Prevention, U.S. Public Health Service.





#### MORNING KEYNOTE: Dr. Robert Lawrence cont'd

In 1996, Dr. Lawrence became the founding director of the Center for a Livable Future at the School of Public Health. The Center is an inter-disciplinary group of faculty and staff that focuses attention on equity, health, and the Earth's resources. Research, education, and advocacy examine the relationships among diet, food production systems, the environment, and human health. In 2002, he was awarded the Albert Schweitzer Humanitarianism Prize.

#### **AFTERNOON SPEAKERS: Food Marketing and Public Health Policy**

**Dr. Brian Cook** • Dr. Cook is a Research Consultant at Toronto Public Health with a primary focus on food issues. He has done research on children's marketing for the Public Health Agency of Canada and is involved in an international research project on children's TV advertising across 12 countries. In 2008, his work on children's marketing led the Toronto Board of Health to unanimously call for a national ban on marketing to children.

**Dr. Susan Linn** • Dr. Linn is Associate Director of the Media Center of the Judge Baker Children's Center and an Instructor in Psychiatry at Harvard Medical School. She has written extensively about the effects of media and commercial marketing on children. In 2006 she received the American Psychological Association's Presidential Citation for her work on behalf of children.

Jeanette Longfield MBE ● Located in London, England, Sustain advocates for food and agriculture policies and practices that enhance the health and welfare of people and animals, improve the working and living environment, promote equity and enrich society and culture. Sustain's Children's Food Campaign is working to protect children from junk food advertising. As Sustain's Co-ordinator, Jeanette liaises with the Food Standards Agency, contributes to a number of food policy committees, and appears regularly in the British media representing a public interest view on food policy issues. In 2007, she was awarded an MBE (Member of the Order of the British Empire) for her work.

**Ève Bédard** • Ève Bédard is the Coordinator for the Quebec Weight Coalition. The Coalition supports public policies for environments that are conducive to a healthy diet, regular physical activity, and a realistic perception of healthy weight, body and spirit. Ms. Bédard will discuss the total ban on commercial advertising to children in the Province of Quebec. She is a lawyer and has worked in journalism, communications and for the Quebec Press Council.





## information at a glance

Conference Location: All conference activities will take place at the Novotel Toronto Centre, 45 The Esplanade (Yonge & Front Sts.), downtown Toronto (<a href="http://www.novotel.com/novotel/fichehotel/gb/nov/0931/fiche hotel.shtml">http://www.novotel.com/novotel/fichehotel/gb/nov/0931/fiche hotel.shtml</a>). **Directions to Hotel:** We encourage attendees to take public transit or carpool to the conference.

By subway/rail, exit Union Station and walk east along Front Street. Turn south on Yonge Street and turn east on The Esplanade (10 minute walk in total). By car (from the West), from Pearson International Airport or Highway 401 Eastbound, exit onto Highway 427 South. Exit Highway 427 onto the Gardiner Expressway (after about 20 minutes). Exit the Gardiner Expressway onto Yonge Street North. Immediately after turning onto Yonge Street, there will be an overpass. Immediately after the overpass turn right onto The Esplanade. The hotel is after the stop sign on the right hand side. By car (from the East), from Highway 401 Westbound, exit onto Don Valley Parkway South. Exit Don Valley Parkway onto the Gardiner Expressway West. Exit onto Yonge Street North. Follow directions as above.
