**Subject:** The City's Welfare Reserves

Given the current deteriorating state of the global economy and the fact that the worst is yet to come in terms of economic and social impacts upon Canadians, it seems prudent for City Council to prepare Toronto and its residents for what may come. City Council must ensure our social safety-nets do not fail. This economic downturn is projected to affect us for the next 2 - 5 years.

City Council must be proactive to make sure we've done all we can to prepare our city for high rates of unemployment, homelessness, malnutrition (especially families), as well as reduced development activity and reduced revenue for the City.

With this in mind, I request the answers to the following information be provided:

- (i) Average monthly caseload for Ontario Works for the calendar year 2008, including month-by-month breakdown;
- (ii) A retrospective comparison of average monthly caseloads since calendar year 1998, budgeted and actual;
- (iii) The dollar amounts contained in the City of Toronto reserve funds for Ontario Works, Ontario Disability Support Program, and all other major supportive reserve funds;
- (iv) A status update of any sectors of City of Toronto operations particularly susceptible to changes in the economy.

Dear Ms. Watkiss:

I have received the Administrative Inquiry from Councillor Michael Walker dated January 15, 2009 entitled "The City's Welfare Reserves".

The average monthly caseloads for Ontario Works for the period 1998 to 2008 are attached in Table #1 based on available information.

My most recent report on the balances and obligations for reserve and reserve funds – third quarter variance report – is available on-line as Budget Committee Report BU40.3 which was before the Budget Committee on November 17, 2008. The current balance in the Ontario Works Reserve Fund (XR2101) is \$1,440,354 which includes the 2008 interest allocation and the Social Services Stabilization Reserve is \$8,271,407. These figures will be finalized when the year-end accounts are closed and audited; however, it is not anticipated that there will be further significant adjustments to either account.

With regard to "a status update of any sectors of the City of Toronto operations particularly susceptible to changes in the economy", I will be submitting a report to the February 19, 2009 meeting of the Budget Committee on this matter.
