Notice was given and the application considered on Wednesday, January 21, 2009, as required by the Planning Act.

THE CONSENT REQUESTED:

This is an application for the division of a parcel of residential lands into two parts for conveyance purposes for the creation of a new residential building lot.

The lands concerned are irregular in shape having 24.55m fronting onto the west side of Cresthaven Drive, an average depth of 35.73m and an area of 766.9m². The lands are described as Lot 449, Registered Plan M-1057 and are designated as Parts 1 and 2 on the Draft Reference Plan attached to this notice.

Part 1 would be irregular in shape, having 12.28m fronting on the west side of Cresthaven Drive, an average depth of 35.73m and an area of 379.7m².

Part 2 would have 12.28m fronting onto the west side of Cresthaven Drive, an average depth of 35.73m and an area of 387.2m².

The existing dwelling would be demolished and a new two storey dwelling is proposed to be constructed on each of the proposed lots.

This application is being considered in connection with Minor Variance applications A0721/08NY and A0722/08NY.
