

Parking Prohibitions: Rollingwood Drive

SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with the City policy or by-laws.

To obtain approval to prohibit parking from 1:00 a.m. to 6:00 a.m. on both sides of Rollingwood Drive, from Mogul Drive to McNicoll Avenue.

The implementation of the parking prohibitions will address the residents' concern regarding vehicles continually parked on both sides of Rollingwood Drive from Mogul Drive to McNicoll Avenue, during the late evening.

RECOMMENDATIONS

Transportation Services Division recommends that North York Community Council:

1. Amend Schedule VIII of By-law No. 31001, of the former City of North York, to prohibit parking, from 1:00 a.m. to 6:00 a.m., on the east side of Rollingwood Drive, between Mogul Drive and McNicoll Avenue; and
2. Amend Schedule VIII of By-law No. 31001, of the former City of North York, to prohibit parking, from 1:00 a.m. to 6:00 a.m., on the west side of Rollingwood Drive, from a point 36 metres south of Mogul Drive to McNicoll Avenue.

FINANCIAL IMPACT

All costs associated with the installation of the parking regulations are included within the Transportation Services Division 2009 Operating Budget.

ISSUE BACKGROUND

Transportation Services Division, North York District, was requested by Councillor David Shiner, on behalf of residents of Rollingwood Drive, to amend parking prohibitions on both sides of Rollingwood Drive, from Mogul Drive to McNicoll Avenue.

COMMENTS

As a result of excessive overnight parking on Rollingwood Drive, residential driveways are being blocked by parked vehicles. The residents have requested that parking be prohibited on both sides between 1:00 a.m. and 6:00 a.m.

The current parking restrictions on Rollingwood Drive are as follows:

- Parking is prohibited from 9:00 a.m. to 4:00 p.m., Monday to Friday on the east side of Rollingwood Drive from the northerly limit of McNicoll Avenue to the southerly limit of Mogul Drive.
- Parking is prohibited at any time on the west side of Rollingwood Drive, between the southerly limit of Mogul Drive to a point 36 metres south of the southerly limit of Mogul Drive.
- Parking is prohibited from 9:00 a.m. to 4:00 p.m., Monday to Friday on the west side of Rollingwood Drive from the northerly limit of McNicoll Avenue to a point 36 metres south of the southerly limit of Mogul Drive.

Rollingwood Drive is classified as a local roadway. The roadway width is currently 8.5 metres. All of the properties along this section of roadway are single family homes.

According to residents, vehicles are continually parked on both sides of Rollingwood Drive during the late evening hours. Parked vehicles on both sides of the road restrict the safe and efficient flow of two-way traffic and also restrict the access/egress at residential driveways.

All of the single family dwellings on Rollingwood Drive have double car garages and large driveways that could accommodate the demand for three hour parking during the late evening hours.

Councillor David Shiner has received majority support from residents to prohibit parking on both sides of Rollingwood Drive during the overnight period of 1:00 a.m. to 6:00 a.m.
