BY-LAW No.

**To name the proposed private street at 2205, 2225, 2235 and 2255 Sheppard Avenue East extending southerly from Sheppard Avenue East as “Atria Boulevard”.**

WHEREAS City of Toronto Council has delegated the legislative authority for local routine matters, such as the naming of streets, to Community Councils by adopting Executive Committee Item 2.5, as amended, at its meeting held on February 5, 6, 7 and 8, 2007; and

WHEREAS pursuant to §27-152E(5) of Chapter 27, Council Procedures, of the City of Toronto Municipal Code, North York Community Council has the authority to pass a by-law naming the streets; and

WHEREAS notice of the proposed by-law to name the said proposed private street was posted on the notices page of the City’s website in accordance with the requirements of City of Toronto Municipal Code Chapter 162, and interested persons were given an opportunity to be heard at a public meeting held on September 15, 2009, and it is appropriate to name the proposed private street at 2205, 2225, 2235 and 2255 Sheppard Avenue East extending southerly from Sheppard Avenue East as “Atria Boulevard”;

The North York Community Council of the City of Toronto HEREBY ENACTS as follows:

1. The private street at 2205, 2225, 2235 and 2255 Sheppard Avenue East extending southerly from Sheppard Avenue East and shown on Attachment No. 1 to this By-law dated April 22, 2009 is named “Atria Boulevard”;
2. Dorsay Development Corporation and 1666500 Ontario Inc., their agents or successors, shall enter into an agreement with the City to pay the City for the costs of fabrication and installation of the appropriate signage estimated to be in the amount of \$300.00; and
3. The owners of the private street or their successors shall maintain at their own risk, the signage installed under section 2 of this By-law.

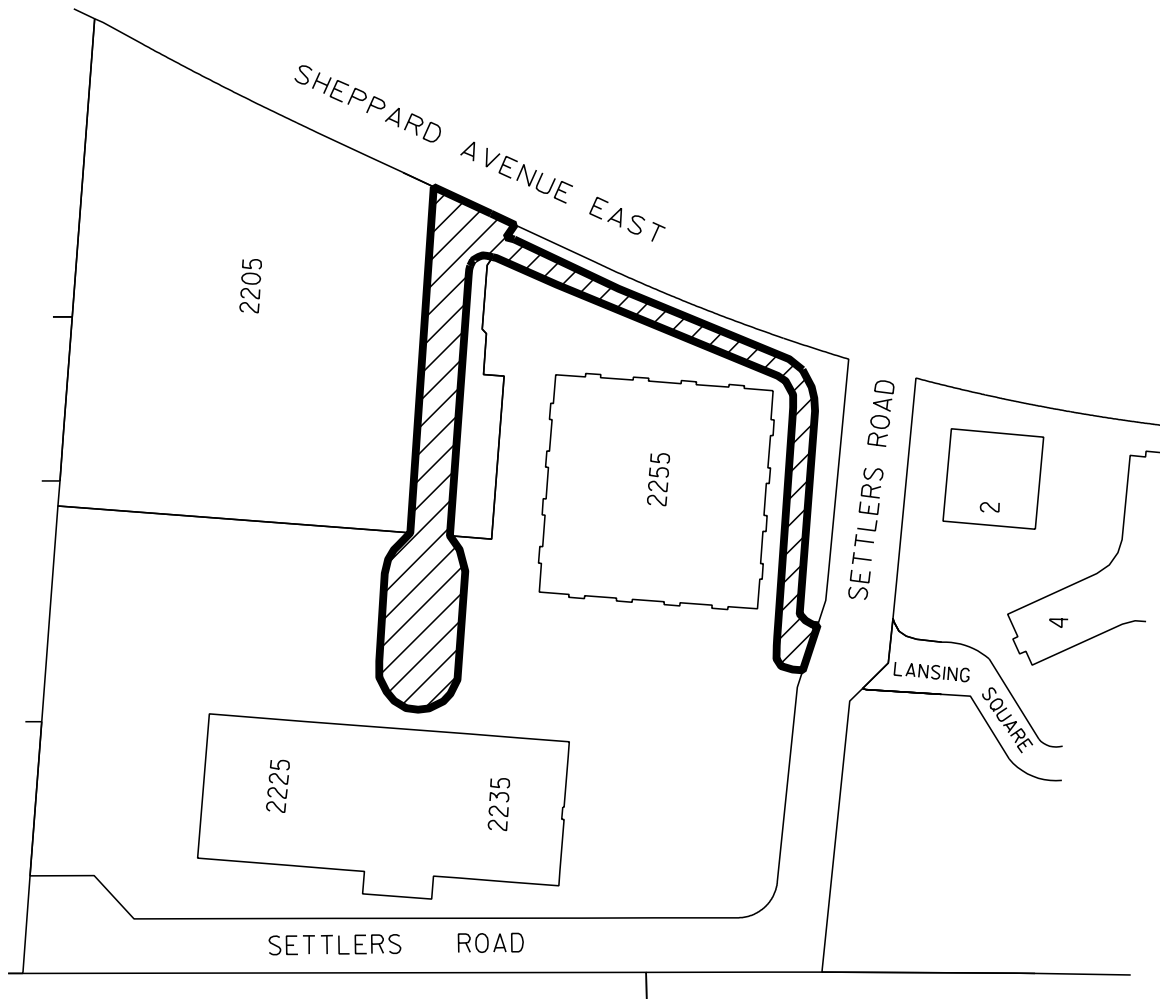
