



## **NOTICE OF MOTION**

## **SUMMARY:**

This motion is about a matter for which the Community Council has delegated authority from City Council to make a final decision, providing that it is not amended so that it varies with City policy or by-laws.

The Transportation Services Division, North York District, has reviewed a request from the Principal of St. Cyril Catholic Elementary School to review the feasibility of implementing short-term parking during the day on the north side of Kempford Boulevard in order to facilitate student pick-up and drop-off activities and to remove the existing school bus loading zone, accordingly.

Currently, on the north side of Kempford Boulevard between Beecroft Road and the driveway to the school, stopping is prohibited between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday, Parking is prohibited at anytime on the north side of Kempford Boulevard between the driveway to the school and Yonge Street. There is currently a school bus loading zone in front of the school that is not utilized.

Our observations have verified the Principal's concern that the existing stopping regulations on the north side of Kempford Boulevard do not facilitate student pick-up and drop-off activities. There are no scheduled school bus pick-up or drop-off activities at this school.

The Transportation Services Division, North York District, would have no objection to amend the current parking/stopping regulations on the north side of Kempford Boulevard to remove the existing no stopping regulations and school bus loading zone and to permit parking for maximum periods of 15 minutes between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday, from a point 55 metres east of Beecroft Road to a point 34 metres east thereof. In addition, this division supports the installation of no parking at anytime prohibitions on the north side of Kempford Boulevard from the east limit of Beecroft Road to a point 55 metres east thereof. The parking of vehicles on the north side of Kempford Boulevard adjacent to St. Cyril Catholic Elementary School for maximum periods of 15 minutes between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday, will not have a negative effect on traffic flow on Kempford Boulevard.

It should be noted that all costs associated with amendments to the parking regulations on the north side of Kempford Boulevard will be included in the Transportation Services Division's 2009 Operating Budget.

## **RECOMMENDATIONS:**

The Transportation Services Division recommends that North York Community Council:

- 1. Amend Schedule IX of By-law No. 31001, of the former City of North York, by deleting the prohibited stopping between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday, on the north side of Kempford Boulevard from the easterly limit of Holcolm Road to 128.15 metres east of the easterly limit of Holcolm Road;
- 2. Amend Schedule VIII of By-law No. 31001, of the former City of North York, to install no parking at anytime prohibitions on the north side of Kempford Boulevard from Beecroft Road to a point 55 metres east thereof;
- 3. Amend By-law No. 32759, of the former City of North York, by deleting the school bus loading zone on the north side of Kempford Boulevard from a point 103.6 metres west of the westerly limit of Yonge Street to a point 18 metres westerly thereof; and
- 4. Amend Schedule X of By-law No. 31001, of the former City of North York, to install permitted parking for maximum periods of 15 minutes between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday, on the north side of Kempford Boulevard from a point 55 metres east of Beecroft Road to a point 34 metres east thereof.
