

## **Parking Prohibitions: Rondeau Drive**

### **SUMMARY**

---

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with City policy or by-laws.

To obtain approval to prohibit parking on the east side of Rondeau Drive, between Sirocco Drive and Francine Drive, from 8:00 a.m. to 4:00 p.m., Monday to Friday.

The parking prohibitions will address the residents' concerns with respect to excessive on-street parking occurring on Rondeau Drive.

### **RECOMMENDATIONS**

---

Transportation Services Division recommends that North York Community Council:

1. Amend Schedule VIII of By-law No. 31001, of the former City of North York, be amended to delete the existing prohibited parking on the west side of Rondeau Drive, between Sirocco Drive and Francine Drive, from 8:00 a.m. to 4:00 p.m. Monday to Friday; and
2. Amend Schedule VIII of By-law No. 31001, of the former City of North York, to prohibit parking on both sides of Rondeau Drive, between Sirocco Drive and Francine Drive, between the hours of 8:00 a.m. and 4:00 p.m., Monday to Friday.

## **FINANCIAL IMPACT**

All costs associated with the parking prohibitions are included within the Transportation Services Division's 2009 Operating Budget.

## **ISSUE BACKGROUND**

Transportation Services Division, North York District, was requested by Councillor David Shiner on behalf of area residents, to review the feasibility of prohibiting parking on east side of Rondeau Drive between Sirocco Drive and Francine Drive.

The residents are concerned that vehicles parked on east side of the roadway during the day restrict the safe and efficient flow of two-way traffic and access/egress to residential driveways.

## **COMMENTS**

Currently, on the east side of Rondeau Drive, between Sirocco Drive and Francine Drive, parking is permitted for periods of up to three hours. On the west side of Rondeau Drive, between Sirocco Drive and Francine Drive, parking is prohibited from 8:00 a.m. to 4:00 p.m., Monday to Friday.

Observations conducted throughout the day have verified the residents' concerns that vehicles are continually parked on the east side of Rondeau Drive immediately south of Francine Drive. Vehicles parked at this location are generated from students of the chiropractic college on Leslie Street.

In order to improve vehicle circulation for two-way traffic and access to residential driveways, it is recommended that parking be prohibited on the east side of Rondeau Drive between Sirocco Drive and Francine Drive from 8:00 a.m. to 4:00 p.m. Monday to Friday.

The installation of parking restrictions on the east side of Rondeau Drive between Sirocco Drive and Francine Drive will improve the flow of two-way traffic and improve access to residential driveways.

Councillor David Shiner supports the recommendations of this staff report.
