(i) Parkway Plaza Grand Union/Metro supermarket

The committee received copies of newpaper articles relating to the listing of the Parkway Plaza "Grand Union" supermarket, including articles by Christopher Hume and John Spears.

A historical review of the history of the Guild Studio was prepared by the Chairman and circulated for members' files. The designated structure was gutted by fire on Christmas Eve, 2008.

The Agincourt HCD sub-committee submitted a list of properties for consideration as additions to the City's Inventory of Heritage Properties. (see S-090207)

4.1 New Business - Scarborough Cenotaph

The Chairman outlined the discussions with staff concerning a proposal to relocation the historic Scarborough Cenotaph in conjunction with proposed intersection improvements at Kingston Road and Danforth Avenue. The committee reviewed the material submitted and discussed various options. Members were unanimous in their agreement that the Cenotaph must remain on its original site and relocated on the same site only as the last option available to ensure its long-term preservation.

"BE IT RESOLVED that the Scarborough Community Preservation Panel approved, in principle, the relocation of the Scarborough Cenotaph, providing it remains in the same general, prominent location with high visibility from both Kingston Road and Danforth Avenue. Further, if it is required to relocate the monument a short distance to the west to accommodate intersection improvements as outlined in proposed Option 6, that consideration be given to providing a small access driveway and small parking area near the Cenotaph for the use of casual visitors, veterans and physically challenged who may wish to visit the site."

It is further recommended that the Toronto Preservation Board endorse the above resolution and forward it to preservation staff for review and future action when required.

4.2 New Business - Malcolm farmhouse @ 2025 Midland

The Chairman summarized discussions with Preservation staff and the solicitor for the owner of the listed property known as the Malcolm farmhouse and located on the north-east corner of Midland Avenue and Ellesmere Road. The building was listed more than 25 years ago and appears to have changed ownership several times with the current owner unaware of the listing. Negotiations for the sale and possible redevelopment of the property are pending,

The Malcolm farmhouse is board and batten frame structure believed to have been built about 1874 by John Holmes and subsequently sold to the Malcolm family, descendants of Scarborough's first permanent settlers David and Mary Thomson. There have been minor alteration to the structure over time including the enclosure of the front (west) verandah and the addition of the brick, external fireplace chimney on the south facade. The exterior is currently clad with vinyl siding in the original board and batten style.

While most members were familiar with the structure, it was agreed to table further discussions to the next meeting to give members an opportunity to revisit the site in order to be better able to make informed decisions regarding the possible future preservation of the structure.
