BY-LAW No.

To Amend Chapter 441 of the Municipal Code

WHEREAS Council has the authority to pass this by-law pursuant to subsections 8(1), (2) and (3) of the *City of Toronto Act, 2006*, S.O. 2006, Chapter 11, Schedule A (the “City of Toronto Act, 2006”);

WHEREAS Council may pass by-laws with respect to any service or thing provided or done by or on behalf of the City pursuant to section 8 of the *City of Toronto Act, 2006*;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 441, Fees and Charges, of the City of Toronto Municipal Code is amended as follows:
 - A. By amending Appendix A – Waste Collection and Disposal Fees and Water and Sewer Usage Rates, Schedule 4 - Wastewater as follows:
 - (1) Item 2, being the Sewer Surcharge Rate shall be deleted and replaced with the following:

(2) A minimum surcharge of \$500.00 for industrial waste surcharge agreements or permits or sanitary discharge agreements or permits, where the total fees for a one year or lesser term calculated in accordance with the rate set out in Item 2 or Item 14, as applicable, of this Schedule are \$500 or less, shall be added as Item 19 as follows:
