TAKE NOTICE THAT:

- 1. The City of Toronto <u>has acquired</u> the private lane at the rear of Premises Nos. 1697 to 1703 St. Clair Avenue West, extending westerly between Premises Nos. 34 and 36 Spring Grove Avenue, shown as PARTS 1 and 2 on Plan 64R-16417, as a local improvement for public lane purposes.
- 2. The cost of the work is \$65,640.57, of which 100 per cent is to be paid by the immediately benefiting lands. The special rate per metre frontage is \$2,554.21, or if spread over a period of 10 years, an annual rate of per metre frontage of \$381.87. If you choose to amortize the payments over 10 year, an annual rate of \$618.25 will be applied to your tax bill. As an alternative, a lump sum payment, estimated to be \$4,135.26 can be made after the above-noted charges are confirmed by the Committee of Revision.
