### Request for a Fence Exemption - 1 Gully Drive

#### Origin

(January 6, 2009) Report from Manager, Municipal Licensing and Standards, Scarborough District

#### Recommendations

Municipal Licensing and Standards, Scarborough District, recommends that Scarborough Community Council:

1. Refuse the existing 2 metre high wood fence located in the front yard based on non-compliance with the requirements set out in Chapter 447 of the Toronto Municipal Code.

#### **Summary**

# 21 and 23 Mastwood Crescent (formerly Buttermill Subdivision, East Side of East Avenue) – Private Tree Removal

#### Origin

(March 25, 2009) Report from Director, Urban Forestry, Parks, Forestry and Recreation

#### Recommendations

The General Manager of Parks, Forestry and Recreation recommends that:

1. City Council approve the request for a permit to remove five (5) privately-owned trees, located at the rear of 21 and 23 Mastwood Crescent (Lots 11 and 12).

#### Summary

This report recommends that Council approve the request for removal of five (5) privately-owned trees. The grade around the trees is to be raised by approximately one metre to address grading and drainage issues on the development site.

Inspection of the trees by staff revealed that they are in fair condition. The grading change proposed for the site will have an impact on the health of the five (5) trees. The additional soil will reduce the amount of oxygen and water that the root systems of the trees receive, resulting in a decline in their health. Urban Forestry supports the request for tree removal so that the owners of the new homes are not left with the burden of removing dead trees in the future.

#### Request to designate 137 Marilake Drive as a Natural Garden

#### Origin

(March 30, 2009) Report from Manager, Municipal Licensing and Standards, Scarborough District

#### Recommendations

Municipal Licensing and Standards, Scarborough District, recommends that Scarborough Community Council:

1. Parks, Forestry and Recreation-Natural Environments, states that in their expert opinion, this location does not meet the provisions to be considered as a natural garden. Therefore, Municipal Licensing and Standards recommends that the exemption be not be granted at this time.

#### Summary

The purpose of this report is to consider a request by the owner(s) of 137 Marilake Drive to be exempted from Chapter 489-Grass and Weeds, section 489-2. This section states that the maximum height of grass and weeds cannot exceed 20 centimetres. This report is to consider this exemption request in accordance with Chapter 489, Grass and Weeds, section 489-3(E)(6) and have their yard(s) designated a Natural Garden, as follows:

- (6) An owner or occupant requesting a review of a notice, and any other interested person, shall be heard by the community council which may:
  - (a) If the land is located in the geographic area of one community council, under delegated authority:
    - [1] Grant the exemption, with or without conditions, and cancel the notice; or
    - [2] Confirm the notice and direct that a second notice be given under this section.

# Conveyance of Rear Portion of 1251 Tapscott Road to Canadian Pacific Railway

#### Origin

(March 11, 2009) Report from Chief Corporate Officer

#### Recommendations

The Chief Corporate Officer recommends that:

- 1. The City convey for nominal consideration Part 2 on Expropriation Plan AT1551966 to CP Rail and that each of the Chief Corporate Officer and the Director of Real Estate Services be authorized severally to sign any documents on behalf of the City to give affect thereto.
- 2. The Director of Real Estate Services be authorized to sign the letter of understanding between the City and CP Rail listing the terms upon which this Property is being transferred by the City to CP Rail. The terms are listed in Appendix "A' attached to this Report.
- 3. City Council, as approving authority under the Expropriations Act, authorize the transfer of the Property to CP Rail without giving the owner from whom the land was taken the first chance to repurchase the Property on the terms of the best offer received by the City.
- 4. City Solicitor be authorized to complete this transaction on behalf of the City including making payment of any necessary expenses, and amending the closing date and other dates to such earlier or later date(s) and on such terms and conditions as she may from time to time consider reasonable.
- 5. The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

#### **Summary**

To replace Canadian Pacific Rail Company's ("CP Rail") spur line rail servicing 1051 Tapscott Road that was lost when a portion of 1051 Tapscott Road was expropriated by the City to extend McNicoll Avenue. The City also expropriated a portion of the rear of 1251 Tapscott Road (PART 2, Expropriation Plan AT1551966, "the Property") and it is now recommended that the transfer of this Property to CP Rail be authorized for the substitute site of the said spur line track.

The expropriated Property was acquired and is being transferred to CP Rail at nominal consideration to minimize damages which may be claimed against the City by the owner and/or tenant of 1051 Tapscott Road arising out of the City's expropriation of a portion of their land to extend McNicoll Avenue and the resultant loss of the original rail spur line.

#### **Financial Impact**

There are no financial implications to the City's budget as a result of this recommendation because this Property being transferred to CP Rail was not acquired at the City's expense. The Morningside Heights Landowners Group ("MHLG") agreed, as a term of the February 22, 2002 Core Servicing Agreement for the Morningside Neighbourhood, to pay for the City's costs to expropriate lands required in connection with the extension of McNicoll Avenue, Easterly of Tapscott Road, which include the cost of the Property now intended to be transferred to CP Rail.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

#### **Summary**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

Transportation Services staff have reviewed the installation of minor street stop signs at other uncontrolled three-way intersections in the Scarborough Village Neighbourhood (Argo Road at Lawndale Road, Coltbridge Court at Markanna Drive, Glenda Road at Lawndale Road, Greendowns Drive at Riant Street, and Knowlton Drive at Lawndale Road).

It is recommended that minor street stop signs be installed at the subject uncontrolled three-way intersections to clearly define the right-of-way and to regulate traffic flow.

#### **Financial Impact**

The financial cost of installing these stop controls is approximately \$1,750.00. The funding for these stop controls is available in the Transportation Services 2009 Operating Budget, within Cost Centre TP0397.

- 1. Approve the installation of Traffic Control Signals at the intersection of Brenynon Way and Wickson Trail/John Tabor Trail.
- 2 Rescind the "Pedestrian Crossover" regulation on Brenyon Way, as identified in Appendix 1 of this report.
- 3. Amend the appropriate by-law(s) accordingly.

#### Summary

This staff report is about a matter for which the Community Council does not have delegated authority from City Council to make a final decision.

This report responds to a request to replace the existing Pedestrian Crossover with an All-Way Stop Control at the intersection of Brenyon Way and Wickson Trail/John Tabor Trail. The report shows that an All-Way Stop Control is warranted at this intersection that is located in the Malvern Neighbourhood.
