# Rescind Left-Turn Prohibition Regulation – 615 Ellesmere Road

### SUMMARY

This staff report is about a matter for which the Community Council does not have delegated authority from City Council to make a final decision.

The purpose of this report is to advise on the need to rescind a northbound No Left Turn regulation at the access to 615 Ellesmere Road.

#### RECOMMENDATIONS

#### Transportation Services, Scarborough District, recommends that Scarborough Community Council recommend that City Council:

- 1. Rescind the "Prohibited Turns" regulation, as identified in the Appendix 1 of this report.
- 2. Pass or amend the appropriate by-law(s) accordingly.

#### **Financial Impact**

There is no financial impact associated with this report.

#### **ISSUE BACKGROUND**

The retail development at 615 Ellesmere Road was approved several years ago with a three-quarter moves access due to safety concerns related to the lack of a centre left-turn lane along Ellesmere Road at that time. This driveway was designed to prevent northbound left-turns out of this site through a channelization island and a signed turn prohibition.

In 2007, Ellesmere Road was widened to seven lanes. At this access, the widening resulted in the removal of the channelization island and the provision of a new centre left-turn lane. The local Councillor has requested staff to study rescinding this prohibition as a result of these environmental changes at this access.

#### COMMENTS

With the widening of Ellesmere Road, there is no longer a need to prohibit this left-turn as the channelization island has been removed and a new centre left-turn lane is now provided. Northbound left-turns can now be made safely out of this access.
