# Rescind No Parking Anytime Regulation – Bamburgh Circle Abutting Terry Fox Park

#### **SUMMARY**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to advise on a request to rescind the current No Parking Anytime prohibition along Bamburgh Circle abutting Terry Fox Park.

#### **RECOMMENDATIONS**

## Transportation Services, Scarborough District, recommends that Scarborough Community Council:

- 1. Rescind the "No Parking" regulation, as identified in Appendix 1 of this report.
- 2. Adopt the "No Parking" regulations, as identified in Appendix 2 of this report.
- 3. Pass or amend the appropriate by-law(s) accordingly.

#### **Financial Impact**

The financial cost of installing the recommended nightly parking prohibition signs is approximately \$2500.00. The funding for these signs is available in the Transportation Services 2008 Operating Budget, within Cost Centre TP0397.

#### **ISSUE BACKGROUND**

Historically, the entire circuit of Bamburgh Circle has had a No Parking Anytime regulation since 1987. At the request of Councillor Mike Del Grande, staff were requested to study allowing parking on the east side of Bamburgh Circle where it abuts Terry Fox Park and part-way along the Bamburgh Circle flankage of Dr. Norman Bethune Collegiate Institute. This would provide short-term on-street parking for park visitors up to three hours, as the park itself has no dedicated off-street parking available.

#### **COMMENTS**

There is no safety hazard associated with allowing this casual parking, which would still be subject to the three-hour maximum parking regulation under the Uniform Traffic By-Law. However, as the park is closed at night, a nightly parking prohibition is being recommended to prevent overnight parking issues.
