## SUMMARY

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to advise on the need to housekeep the lack of valid by-law for the existing signage in the field.

## RECOMMENDATIONS

**Transportation Services, Scarborough District, recommends that Scarborough Community Council:** 

- 1. Enact the "Prohibited Turns" Regulations as identified in Appendix 1 of this report.
- 2. Pass or amend the appropriate by-law(s) accordingly.

#### **Financial Impact**

There is no financial impact associated with this report.

#### **ISSUE BACKGROUND**

In the process of studying various traffic concerns on Eglinton Avenue East in the McCowan Road area, a by-law search revealed that the existing Westbound No Left-Turn and Northbound No Right-Turn signage at the driveway of 2911 Eglinton Avenue East exiting on Landmark Boulevard is not accompanied by appropriate by-laws. This driveway is physically constructed to curtail these turns.

#### COMMENTS

In order to make the existing signage enforceable, Westbound No Left-Turn and Northbound No Right-Turn prohibitions should be enacted.

Landmark Boulevard at driveway exiting from 2911 Eglinton Avenue East	Northbound	Right	Anytime
