SUMMARY

This staff report is about a matter for which the Community Council does not have authority from City Council to make a final decision.

The purpose of this report is to advise on the need to housekeep the lack of a valid by-law for the existing speed limit signage in the field.

RECOMMENDATIONS

Transportation Services, Scarborough District, recommends that Scarborough Community Council recommend that City Council:

- 1. Rescind the "40 km/h speed limit" Regulation on Brimley Road South as identified in Appendix 1 of this report.
- 2. Enact the new dimensions for the "40 km/h speed limit" Regulation as identified in Appendix 2 of this report.
- 3. Amend the appropriate by-laws accordingly.

Financial Impact

There is no financial impact associated with this report.

ISSUE BACKGROUND

In the process of studying various traffic concerns on Brimley Road South, south of Kingston Road area, a by-law search revealed that the existing 40 km/h speed limit signing begins at Kingston Road and not at Barkdene Hills as documented in the by-laws.

COMMENTS

In order to make the existing signage enforceable, we are rescinding the original by-law and enacting a new 40 km/h speed limit that reflects the existing signage on Brimley Road South.
