**Realignment of Permit Parking Area 7E to Exclude
90-100 Broadview Avenue**

SUMMARY

To respond to a request from Toronto City Council to report back to the Toronto and East York Community Council on February 9, 2009, on the realignment of Permit Parking Area 7E to exclude the municipal addresses of 90-100 Broadview Avenue.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. approve the amendment of Schedule B of Municipal Code Chapter 925 to incorporate a revised map of Permit Parking Area 7E, as attached in Appendix ‘A’ of this report.

Financial Impact

There is no financial impact associated with this report.

ISSUE BACKGROUND

Toronto City Council, at its meeting of December 1, 2 and 3, 2008, in considering a report (December 1, 2008) from the Chief Planner and Executive Director, City Planning Division, entitled “90-100 Broadview Avenue - Zoning Application – Supplementary Report”, requested Transportation Services to examine and report back to the Toronto and East York Community Council on February 9, 2009, regarding the realignment of parking area 7E, and the exclusion of the subject site from the parking area. (Item TE20.14 of City Council meeting No. 27.)

COMMENTS

Permit Parking Area 7E is bounded by Queen Street East, Logan Avenue, the Gardiner Expressway and the East Don Roadway. This permit area has a total of 309 on-street parking spaces. To date 216 parking permits have been issued to residents of this area. Permit parking records reveal that this area does not have a history of being waitlisted, meaning that the demand for overnight on-street parking permits has never exceeded the supply of parking spaces. Permit parking records also reveal that there are no permit holders for the municipal address 90-100 Broadview Avenue.

Chapter 925, Permit Parking, of the City of Toronto Municipal Code, requires the City Clerk to place a Public Notice in a major newspaper requesting those that object to exclusion of 90-100 Broadview Avenue from Permit Parking Area 7E forward their objection in writing to the City Clerk so they may be scheduled as deputations to the February 9, 2009 Toronto and East York Community Council meeting.

A Public Notice was placed in a major newspaper on December 17, 2008, with an expiration date of December 31, 2008. The Clerk has confirmed that no written objection was received by the expiration date.

Given the result of the Public Notice, Transportation Services has no objection to the exclusion of 90-100 Broadview Avenue from Permit Parking Area 7E.
