Business Improvement Area (BIA) Boards of Management - Various Additions and Deletions

SUMMARY

The purpose of this report is to recommend Toronto and East York Community Council establish Boards of Management for the Mount Pleasant BIA and Queen Street West BIA, appoint members to those Boards, and approve additions and deletions to the Beach, Danforth Mosaic, Dundas-Bathurst, Dundas West, Pape Village, St. Lawrence Market Neighbourhood, and West Queen West BIA Boards of Management. The Toronto and East York Community Council has delegated authority to make final decisions regarding BIA appointments.

RECOMMENDATIONS

The Director of Business Services recommends that:

- 1. Toronto and East York Community Council establish Boards of Management for the Mount Pleasant and Queen Street West BIAs as set out in Attachment No. 1.
- 2. Toronto and East York Community Council approve the nominations to the Mount Pleasant and Queen Street West BIAs and additions and deletions to the Beach, Danforth Mosaic, Dundas-Bathurst, Dundas West, Pape Village, St. Lawrence Market Neighbourhood, and West Queen West Boards of Management as set out in Attachment No. 1.
- 3. Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to include the new Mount Pleasant and Queen Street West BIAs and to reflect the changes to the BIA Boards of Management.

Financial Impact

There are no financial implications resulting from the adoption of this report.

ISSUE BACKGROUND

From time to time, it is necessary to establish new BIA Boards of Management, remove members who are no longer able to serve from existing Boards and add new members to fill vacant positions.

City Council established the Mount Pleasant BIA and Queen Street West BIA on December 3, 2008. The new BIAs held Annual General Meetings on March 2, 2009 and February 10, 2009, respectively, and elected Board members in accordance with Chapter 19 of the City of Toronto Municipal Code.

Attachment No. 1 of this report sets out amendments to Schedule "A", Chapter 19 of the Municipal Code establishing the number of members of the Mount Pleasant and Queen Street West BIA Boards of Management and the number of members required for quorum. The list of Board nominees is included in Attachment No. 2.

COMMENTS

The Beach, Danforth Mosaic, Dundas-Bathurst, Dundas West, Mount Pleasant, Pape Village, Queen Street West, St. Lawrence Market Neighbourhood, and West Queen West BIAs are governed by the Toronto and East York Community Council.

The resignation of one member from the Beach BIA Board of Management will require a change to the number of Board members from 10 to 9 (including one councillor). Quorum will be unchanged.

The resignation of one member from the Danforth Mosaic BIA Board of Management will require a change to the number of Board members from 16 to 15 (including four councillors). Quorum will be reduced from 6 to 5.

The resignation of one member from the Dundas-Bathurst BIA Board of Management will require a change to the number of Board members from 14 to 13 (including one councillor). Quorum will be unchanged.

The addition of one member to the Dundas West BIA Board of Management will require a change to the number of Board members from 15 to 16 (including one councillor). Quorum will be unchanged.

It is recommended that Toronto and East York Community Council establish a Board of Management for the Mount Pleasant BIA consisting of 13 members (including one councillor), with a quorum of 5.

The resignation of two members and addition of one member to the Pape Village BIA Board of Management will require a change to the number of Board members from 8 to 7 (including one councillor). Quorum will be unchanged.

It is recommended that Toronto and East York Community Council establish a Board of Management for the Queen Street West BIA consisting of 11 members (including 1 councillor), with a quorum of 6.

The resignation of one member and addition of one member to the St. Lawrence Market Neighbourhood BIA Board of Management will not affect the number of Board members or quorum.

The resignation of six members and addition of five members to the West Queen West BIA Board of Management will require a change to the number of Board members from 17 to 16 (including two councillors). Quorum will be unchanged.
