

NOTICE OF MOTION

Changes to Alternate Side Parking Regulations on Marchmount Road, between Davenport Road and Shaw Street

SUMMARY:

This motion is to request the Toronto and East York Community Council to rescind the 15 day alternate side parking regulations on Marchmount Road, between Davenport Road and Shaw Street, and replace them with Thursday alternate parking regulations.

This section of Marchmount Road was previously Thursday alternate side parking. The majority of Marchmount Road residents want Thursday alternate parking to be reinstated in order to maximize the number of parking spaces available on the street. Reinstating Thursday alternate parking would mean that more days per month parking will be permitted on the side of the road with the higher number of parking spaces available.

REQUIRES RE-OPENING:

Current regulations were approved at the Toronto and East York Community Council meeting held on November 18, 2008, (Item No. 20.64)

RECOMMENDATIONS:Regulations to be Rescinded:

1. “No parking from the 1st day to the 15th day of each month, April 1 to November 30, inclusive”, on the south and east side of Marchmount Road, from Shaw Street to Davenport Road;
2. “No parking from the 16th day to the last day of each month, April 1 to November 30, inclusive and from December 1 of one year to March 31 of the

next following year” on the north and west side of Marchmount Road, from Shaw Street to Davenport Road;

3. “Parking by permit only, from 12:01 a.m. to 7:00 a.m., daily, from the 1st day to the 15th day of each month, from April 1 to November 30, inclusive”, on the even (north and west) side of Marchmount Road, from Shaw Street to Davenport Road; and
4. “Parking by permit only, from 12:01 a.m. to 7:00 a.m. daily, from the 16th day to the last day of each month, from April 1 to November 30, inclusive and from December 1 of one year to March 31 of the next following year”, on the odd (south and east side) of Marchmount Road, from Shaw Street to Davenport Road.

Regulations to be Implemented:

1. Prohibit parking each Thursday, from April 1 to November 30, inclusive, on the east and south side of Marchmount Road, from Davenport Road to Shaw Street;
2. Prohibit parking anytime, except each Thursday, from April 1 to November 30, inclusive, on the west and north side of Marchmount Road, from Davenport Road to Shaw Street;
3. Allow parking by permit only, from 12:01 a.m. to 7:00 a.m., all times, except each Thursday, from April 1 to November 30, inclusive, on the odd side of Marchmount Road, from Davenport Road to Shaw Street; and
4. Allow parking by permit only, from 12:01 a.m. to 7:00 a.m., each Thursday, from April 1 to November 30, inclusive, on the even side of Marchmount Road, from Davenport Road to Shaw Street.
