SUMMARY

This staff report is about a matter which Community Council has been delegated authority from City Council to make a final decision.

Transportation Services has been requested by Deputy Mayor Joe Pantalone to enact one-hour maximum parking on the east side of Roxton Road, between Dundas Street West and Harrison Street, to operate between the hours of 8:00 a.m. to 6:00 p.m., Monday to Friday.

This regulation will restrict the amount of time non-permit holders can park on Roxton Road during the weekday daytime periods, potentially enhancing parking opportunity for residents. Permit holders are exempt from this regulation.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. Approve implementation of a “One-hour maximum parking, from 8:00 a.m. to 6:00 p.m., Monday to Friday” regulation on the east side of Roxton Road, between Dundas Street West and Harrison Street.

ISSUE BACKGROUND

Transportation Services was requested by Deputy Mayor Joe Pantalone to enact a one-hour maximum parking regulation on the east side of Roxton Road, between Dundas Street West and Harrison Street, to operate between the hours of 8:00 a.m. to 6:00 p.m., Monday to Friday.

COMMENTS

Roxton Road, between Dundas Street West and Harrison Street, is a local roadway that operates one-way in the northbound direction. It has a daily one-way traffic volume of about 1,200 vehicles and a speed limit of 40 km/h. There is no TTC service on Roxton Road. Parking is prohibited at all times on the west side of Roxton Road. Permit parking regulations are in effect between the hours of 12:01 a.m. to 7:00 a.m., daily on the east side of the street. At all other times, parking is allowed for a maximum of 3 hours on the east side of Roxton Road.

Residents on Roxton Road have expressed concern about non-local motorists parking on this street during the daytime hours. Implementing a one-hour maximum parking regulation from 8:00 a.m. to 6:00 p.m., Monday to Friday will restrict parking duration, potentially discourage non-resident parkers, and enhance parking opportunity for residents during the daytime. This regulation will still allow non-residents to park during the evening and weekend periods for up to 3 hours. Resident permit holders are exempt from the one-hour maximum parking regulation.
