Rescind Overnight On-Street Permit Parking – Mount Pleasant Road

SUMMARY

Transportation Services is requesting approval from City Council to rescind overnight on-street permit parking on the eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue.

Area residents requested the removal of on-street overnight permit parking on the eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue, as they feel there is no longer a need for permit parking.

RECOMMENDATIONS

Transportation Services recommends to City Council that:

1. Schedule A of Municipal Code Chapter 925, Permit Parking, be amended by deleting the eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue.

Financial Impact

The adoption of the above-noted recommendation has no financial impact.

ISSUE BACKGROUND

A request was received from Councillor Michael Walker, on behalf of area residents, to rescind overnight on-street permit parking on the eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue.

COMMENTS

The eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue, operates in a one way northbound direction, on a pavement width of 7.3 metres with TTC service in operation. Parking is allowed on the east side of the street for a maximum period of one hour from 10:00 a.m. to 6:00 p.m., Monday to Friday, and is allowed for 3 hours at other times. Overnight on-street permit parking is in effect from 2:01 p.m. to 10:00 p.m., Monday to Friday.

A Public Notice was placed in a major newspaper on April 27, 2009, with an expiration date to raise objections of May 11, 2009. The Clerk has confirmed that no written objection was received by the expiration date.

Area residents requested overnight on-street permit parking be rescinded on the eastern branch of Mount Pleasant Road, between Balliol Street and Davisville Avenue, as they feel the permit parking program is no longer required by area residents. There are currently eight on-street parking spaces and no permit holders on this section of Mount Pleasant Road.
