Dear Kimberly Kilburn,

Re: Application to transfer the patio licence for the boulevard cafe located at 298 Brunswick Avenue

I am writing to ask you to refuse the application to transfer the patio license at 298 Brunswick Avenue, which is operating as the Labyrinth Lounge.

The establishment at 298 Brunswick has been the source of complaints around excessive noise over the past few years. While the Labyrinth Lounge is not the only establishment that is the source of noise in the area, residents have reported that noise from its patio has contributed to their inability to enjoy their property and get a good night's sleep.

In January, the owner held a public meeting to address community concerns about the patio. At the end of the meeting, interested residents were invited to join a working group that would negotiate hours and conditions for the patio that would be amenable to the local community.

On April 3, the residents offered the owner a compromise. he could open his patio if he closed at 11:00 (the as-of-right patio hours) and if he met a number of conditions aimed at reducing noise. The owner refused the offer.

After this meeting, the residents no longer felt that the owner was willing to work with them or take their concerns seriously. As a result, the working group's support for a patio vanished, and I received petitions, emails and letters asking me to deny the owner a patio license.

It is for these reasons that I am asking you to refuse the application.

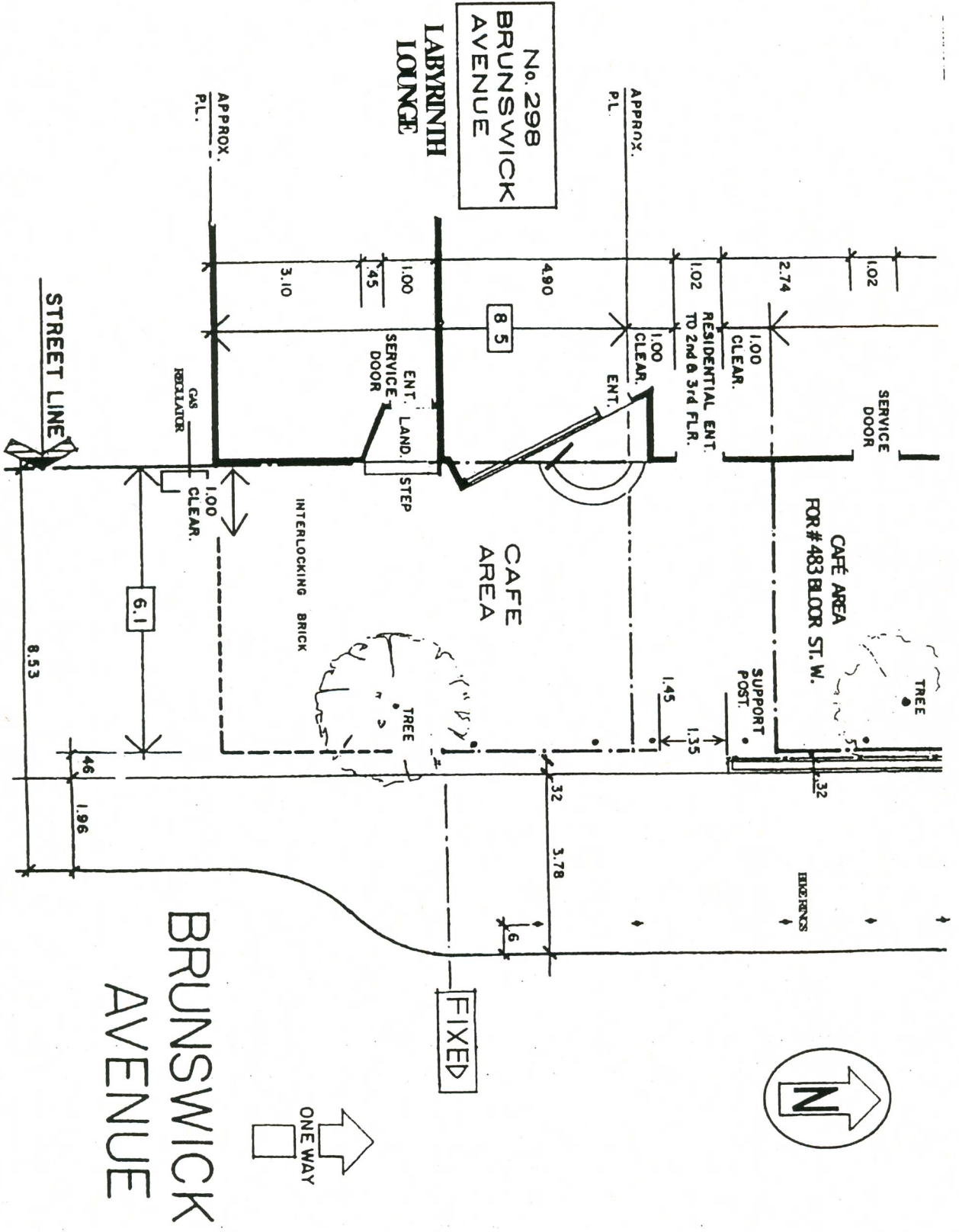
