# Naming of Proposed Public Streets East of Brockville Street, Between Enroutes Street and Belleville Street

## SUMMARY

This staff report is report is about a matter for which the community council has delegated authority from City Council to make a final decision. The report recommends that the proposed public streets east of Brockville Street, between Enroutes Street and Belleville Street be named "Carnahan Terrace" and "Philpott Gardens".

## RECOMMENDATIONS

The City Surveyor recommends that:

- (1) the proposed public streets east of Brockville Street, between Enroutes Street and Belleville Street be named "Carnahan Terrace" and "Philpott Gardens"; and
- (2) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto, including the introduction of by-law.

## **Financial Impact**

There are no financial implications resulting from the adoption of this report.

#### **ISSUE BACKGROUND**

We have a request from Ambercroft Construction Limited (80 Tiverton Court, Suite 300, Markham, Ontario L3R 0G4) to name the two proposed public streets located east of Brockville Street, between Enroutes Street and Belleville Street, as shown on Attachment No. 1. Naming the streets will facilitate the identification of the proposed units fronting thereon.

The proposed names relate to the early history of the Village of East Toronto, incorporated on January 1st, 1888, and were previously approved by Police, Fire and EMS for this area of Ward 32. The names recognize two individuals: F. V. Philpott, Councillor, elected in 1897 and W. J. A. Carnahan - Councillor, elected in 1897.

#### COMMENTS

The proposed names have been circulated for comment and are acceptable to Councillor Sandra Bussin, the Toronto and East York Preservation Panel, Ambercroft Construction Limited, Police, Fire and Emergency Medical Services.

The names conform with item 1 (a), Criteria For Name Selection, as set out in City Council's street naming policy – "to honour and commemorate noteworthy persons associated with the City of Toronto".

The proposed names are consistent with the City of Toronto Street Naming Policy approved by City Council at its meeting held on August 1, 2, 3 and 4, 2000 and amended May 30, 31 and June 1, 2001 and should therefore be approved for identifying the proposed streets.
