**Introduction of Overnight On-Street Permit Parking –
Ava Road**

SUMMARY

This staff report is about a matter which community council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to introduce overnight on-street permit parking on the north side of Ava Road, between Glen Cedar Road and Westover Hill Road, under the operating hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

Area residents requested the implementation of overnight on-street permit parking on the north side of Ava Road, between Glen Cedar Road and Westover Hill Road, to accommodate their long term parking needs without being subject to tagging by Parking Enforcement.

RECOMMENDATIONS

Transportation Services recommends to Toronto and East York Community Council that:

1. Schedule A of Municipal Code Chapter 925 be amended to incorporate Ava Road, between Glen Cedar Road and Westover Hill Road, under the operating hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

ISSUE BACKGROUND

A request was received from Councillor Joe Mihevc, on behalf of area residents for the introduction of overnight on-street permit parking on Ava Road, between Glen Cedar Road and Westover Hill Road, with the operating hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

COMMENTS

Ava Road, between Glen Cedar Road and Westover Hill Road, is a local roadway operating a two-way east/westbound direction with a pavement width of 8.5 metres. There is no TTC service on Ava Road, between Glen Cedar Road and Westover Hill Road. Parking is allowed on the north side of Ava Road, between Glen Cedar Road and Westover Hill Road for a maximum period of three hours. Parking is prohibited at anytime on the south side of the street.

Under the provisions of Municipal Code Chapter 925, Permit Parking, we are required to conduct a poll of the residents to determine if there is support to introduce permit parking.

Ballots were mailed on August 13, 2009, with the last day for filing a response being September 11, 2009. The results of the poll are as follows:

A field survey has determined that there are ten (14) potential on-street parking spaces available on the north side of Ava Road, between Glen Cedar Road and Westover Hill Road.

The majority of area residents returned their ballots in favour of the introduction of overnight on-street permit parking on Ava Road, between Glen Cedar Road and Westover Hill Road, to accommodate their long term need for on-street parking.
