Decision Advice and Other Information

The Aboriginal Affairs Committee on May 27, 2010, unanimously endorsed the proposed (May 7, 2010) City of Toronto Statement of Commitment to Aboriginal Communities in Toronto.

The Committee established a Sub-Committee which worked with City staff to develop a consultation process through which feedback was given by members of Aboriginal communities in Toronto and other stakeholders. The Sub-committee recommended that the Aboriginal Affairs Committee endorse the proposed Statement.

Members of the Aboriginal Affairs Committee noted that this proposal is forward looking in addition to being groundbreaking and places the City of Toronto in a leadership position regarding municipal Aboriginal relationships.

Members of the Committee are looking forward to working closely with the City on the development of the proposed Action Plan which is intended to give effect to the commitments outlined in the statement.

Kenn Richard, Executive Director, Native Child and Family Services and Andre Morriseau, National Aboriginal Achievement Foundation, members of the Committee, will be attending the Executive Committee meeting on June 14, 2010, to lend their support and represent the Aboriginal Affairs Committee.
