Description:

The purpose of this report is to request Bid Committee to grant authority to award and authorize staff to exercise the two additional separate one (1) year options for Contract 47014212 for the period March 1, 2010 to February 28, 2011, and from March 1, 2011 to February 29, 2012 under the same terms and conditions with the current supplier, Neil Vanderkruk Holdings Inc. o/a Connon Nurseries, for the supply, delivery and off-loading of Native Trees and Shrubs to various locations for the City of Toronto Parks, Forestry & Recreation Division.

Date: March 10, 2010

A RFQ for the supply, delivery and off-loading of Native Trees and Shrubs was issued February 16, 2009 with the option to renew for two (2) additional (1) one year periods. An award was made to Neil Vanderkruk Holdings Inc. o/a Connon Nurseries in the amount of \$188,978.62 net of GST (and all taxes) from March 25, 2009 to February 28, 2010.

The award for the two (2) additional separate one (1) year periods was not originally reported to the Bid Committee. Since the contract total including the two (2) option years exceeds the \$500,000.00 (exclusive of all taxes and charges), Parks, Forestry & Recreation Division requires a Bid Committee report to move forward with the option year renewal. Should the final option to renew be exercised, then the General Manager, of Parks, Forestry & Recreation will instruct the Director of Purchasing and Materials Management to process the final renewal under the same terms and conditions.

The total potential contract award identified in this report is \$381,736.81 exclusive of all taxes and charges. The potential cost to the City net of GST and HST Recoveries is \$387,346.71. Funding in the estimated amount of \$191,195.97 net of GST and HST Recoveries required for Option Year one (1) for the period from, March 1, 2010 to February 28, 2011 is included in the Recommended 2010 Parks, Forestry Recreation Operating Budget in account P00034, cost element 2560.
