### SUMMARY

As noted in my report of January 15, 2010 (Item CC45.2), the purpose of this report is to seek further instruction for the upcoming Ontario Municipal Board (OMB) Hearing on the above noted matter scheduled to commence on February 23, 2010.

### RECOMMENDATIONS

The City Solicitor recommends that:

- 1. Council adopt the confidential instructions in Attachment 1.
- 2. Council authorize the public release of the confidential instructions together with Appendix A, if adopted by Council.

### FINANCIAL IMPACT

The recommendations will have no financial impact beyond what has already been approved in the current year's budget.

### **DECISION HISTORY**

The applications before the Board are for a Zoning By-law Amendment and Draft Plan of Subdivision and propose a mixed-use development including retail space.

At its meeting of December 1, 2, 4, and 7, 2009, City Council adopted item NY29.33, directing the City Solicitor and other City Staff to attend the OMB hearing for the above noted matter to oppose the proposed Zoning By-law Amendment and Draft Plan of Subdivision. City Council also directed the City Solicitor and City Staff to meet with the applicant and the community to scope out a possible settlement for the matter.
