#### **DECISION HISTORY**

At its meeting of April 27, 2010, North York Community Council requested the General Manager, Parks, Forestry and Recreation to report directly to City Council for its meeting on May 11 and 12, 2010 on the breakdown of funds allocated under the Federal Stimulus program, Recreational Infrastructure Canada (RInC), for Armour Heights Community Centre.

#### **ISSUE BACKGROUND**

Parks Forestry and Recreation (PF&R) was successful in its application for Recreational Infrastructure Canada (RInC) funding for Armour Heights Community Centre in the amount of \$635,000.00, of which \$209,733.00 was received from each of the Provincial and Federal Governments and \$215,534.00 from the City. The funding breakdown will be as follows:

- 10% (or approximately \$63,500.00) for consultant fees; and
- the balance of \$571,500.00 for construction.

### COMMENTS

The scope of work planned at Armour Heights Community Centre includes rehabilitation of the following components: skylights, sealant & caulking, interior flooring, ceilings, interior walls, millwork, forced air cooling and heating system, central HVAC control, thermostats, new hot water system, fire alarm system, sprinklers, fire hose cabinets, siamese connection, smoke detectors, fire line, security system, and site lighting fixtures.

The work identified and submitted through RinC was a planned capital project that was scheduled to be performed as part of PF&R's ongoing State of Good Repair Program for 2010.
