As Director of the Strategic Policy Branch of the Ontario Ministry of the Environment and Co-Chair of the Ontario Regional Adaptation Collaborative (RAC) Coordinating Committee, I am writing on behalf of the organizations involved in the Ontario RAC to express our appreciation of Toronto's support of our initiative and to encourage the continuation of the City's involvement with this program.

The Ontario Regional Adaptation Collaborative was implemented through a federal contribution agreement between Natural Resources Canada and the Ontario government.
