# **Humber Boulevard South – Parking Regulation Amendment**

#### **SUMMARY**

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to allow three-hour parking anytime on the south side of Humber Boulevard South, in front of 101 Humber Boulevard South only, from a point 85 metres east of Hilldale Road to a point 65.5 metres further east.

This parking regulation amendment will extend the existing three-hour parking period in front of 101 Humber Boulevard South from the evening and night time (6:00 p.m. to 7:00 a.m.) to the whole day (anytime.)

#### RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the existing "No Parking, 7:00 a.m. to 6:00 p.m., Daily" regulation on the south side of Humber Boulevard South, from 85 metres east of Hilldale Road to 65.5 metres further east.

#### **ISSUE BACKGROUND**

On September 15, 2009, Etobicoke York Community Council adopted Item 29.28, in which Transportation Services staff recommended three-hour parking from 6:00 p.m. to 7:00 a.m. daily, on the south side of Humber Boulevard South, from 85 metres east of Hilldale Road to 65.5 metres further east.

Staff's recommendation responded to a request from the Ward Councillor to provide evening and night time on-street parking for residents and visitors of the multi-dwelling residential building occupying 101 Humber Boulevard South. The "No Parking" regulation that previously existed on Humber Boulevard South was maintained from 7:00 a.m. to 6:00 p.m.

On April 1, 2010, staff of Transportation Services received another request from the Ward Councillor, including a petition signed by residents at 101 Humber Boulevard South, to extend the 6:00 p.m. to 7:00 a.m. three-hour parking on Humber Boulevard South to the entire 24-hour period. A map of the area is Attachment 1.

#### COMMENTS

Humber Boulevard South, between Hilldale Road and Avon Avenue, is an 8.7 metre wide, two-lane, two-way collector road with sidewalks on both sides and a posted speed limit of 40 km/h. The road provides access to residential properties and a secondary school in this area.

Parking is prohibited from 7:00 a.m. to 6:00 p.m., daily on the south side of Humber Boulevard South, from 85 metres east of Hilldale Road to 65.5 metres further east (in front of 101 Humber Boulevard South.) Parking is prohibited anytime everywhere else on Humber Boulevard South between Hilldale Road and Avon Avenue.

Allowing three-hour parking anytime on the south side of Humber Boulevard South, between 85 metres east of Hilldale Road to 65.5 metres further east, has no significant traffic operation impacts, and the proposal is supported by the Ward Councillor.
