Ennerdale Road, east side, between a point 30 metres south of Eglinton Avenue West and Dynevor Road – Parking Regulation Amendment

SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to allow three-hour parking anytime on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West.

This parking regulation amendment will replace the one hour maximum parking from 8:00 a.m. to 7:00 p.m. currently posted on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West with the unsigned, City-wide three-hour parking limit.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the existing “One Hour Parking, 8:00 a.m. to 7:00 p.m., Daily” regulation on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West.

ISSUE BACKGROUND

Staff of Transportation Services received a request from the Ward Councillor, to rescind the existing one hour maximum parking from 8:00 a.m. to 7:00 p.m., daily on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West, and by doing so, creating an unsigned three-hour maximum parking limit. A map of the area is Attachment 1.

COMMENTS

Ennerdale Road, between Dynevor Road and Eglinton Avenue, is an 8.7 metre wide, two-lane, two-way local road with sidewalks on both sides and a posted speed limit of 40 km/h. The road provides access to residential properties and a secondary school in this area.

Standing is prohibited at all times on the west side of Ennerdale Road, between Eglinton Avenue West and Branstone Road (north junction). Parking is prohibited at all times on the west side of Ennerdale Road, between Dynevor Road and Branstone Road (north junction). Standing is prohibited at all times on the east side of Ennerdale Road, between Eglinton Avenue West and a point 30 metres south of Eglinton Avenue West. Parking is allowed for a maximum period of one hour from 8:00 a.m. to 7:00 p.m. daily, on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West. Permit Parking is in effect on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West, from 12:00 midnight to 6:00 a.m., daily. During other times parking is allowed for a maximum period of three hours.

Allowing three-hour parking anytime on the east side of Ennerdale Road, from Dynevor Road and a point 30 metres south of Eglinton Avenue West, has no significant traffic operation impacts, and the proposal is supported by the Ward Councillor.
