SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to propose the removal of the existing “No Parking, 10 a.m. to 6 p.m., Monday to Saturday” prohibition on the west side of Kingscourt Drive between Bloor Street West and King Georges Road.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the “No Parking, 10 a.m. to 6 p.m., Monday to Saturday” prohibition on the west side of Kingscourt Drive between Bloor Street West and King Georges Road.

ISSUE BACKGROUND

Transportation Services received a request from Councillor Peter Milczyn, including a petition signed by the majority of residents on the street, requesting that the existing “No Parking, 10 a.m. to 6 p.m., Monday to Saturday” prohibition on the west side of Kingscourt Drive, between Bloor Street West and King Georges Road, be removed. A map of the area is Attachment 1.

COMMENTS

Kingscourt Drive is classified as a two-way local road in the residential community to the north of Bloor Street West and east of Prince Edward Drive. The road is approximately 7.3 metres wide, built to rural standards (ditches and swales) with a sidewalk located on the west side of the street. Kingscourt Drive is one block in length in which parking is prohibited at all times on the entire east side. Parking is currently prohibited on the west side of Kingscourt Drive between 10 a.m. and 6 p.m., Monday to Saturday, with all other times being subject to the unsigned three-hour maximum by-law.

The petition submitted by the area residents indicate that a total of 7 of the 10 homes which have frontage on the west side Kingscourt Drive, signed the petition in favour of removing the parking regulation in front of their homes. In addition, a total of 11 of the 17 homes with direct frontage onto Kingscourt Drive signed the petition indicating support.

Based on the support of the petition and in consultation with the area councillor, it is recommended that the “No Parking, 10 a.m. to 6 p.m., Monday to Saturday” be removed from the west side of Kingscourt Drive between Bloor Street West and King Georges Road. This will result in parking being permitted on the west side of Kingscourt Drive for a maximum of three hours, subject to the unsigned parking by-law.
