SUMMARY

The purpose of this report is to recommend Etobicoke York Community Council approve the additions and deletions to the Kingsway, Mimico by the Lake, Regal Heights Village and St. Clair Gardens BIA Boards of Management. The Etobicoke York Community Council has delegated authority to make final decisions regarding BIA appointments.

RECOMMENDATIONS

The Director of Business Services recommends that:

1. Etobicoke York Community Council approve the additions and deletions to the Kingsway, Mimico by the Lake, Regal Heights Village and St. Clair Gardens BIA Boards of Management as set out in Attachment No. 1.
2. Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to reflect the changes to the BIA Board of Management.

Financial Impact

There are no financial implications resulting from the adoption of this report.

ISSUE BACKGROUND

From time to time, it is necessary to remove BIA Board of Management members who are no longer able to serve, add new members to fill vacant positions, and revise the size of BIA Boards and the number required for quorum as set out in Chapter 19 of the City of Toronto Municipal Code.

COMMENTS

The Kingsway, Mimico by the Lake, Regal Heights Village and St. Clair Gardens BIA Boards of Management are governed by the Etobicoke York Community Council.

The addition of one member and deletion of one member to the Kingsway BIA Board of Management does not require a change to the number of Board Members, and the quorum remains unchanged.

The addition of one member to Mimico by the Lake BIA does require a change to the number of Board Members, however the quorum remains unchanged at 3.

The addition of one member and the deletion of one member to the Regal Heights Village BIA Board of Management does not require a change to the number of Board Members, and the quorum remains unchanged.

The addition of one member and the deletion of one member to the Regal Heights Village BIA Board of Management does not require a change to the number of Board Members, and the quorum remains unchanged.
