SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to propose the installation of a “No Standing, 4:00 p.m. to 9:00 p.m., Monday to Friday” prohibition on the east side of Kings Lynn Road between Bloor Street West and a point 47 metres north of Bloor Street West.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the regulation authorizing the operation of parking meter machines from 9:00 a.m. to 6:00 p.m., Monday to Saturday on both sides Kings Lynn Road between Bloor Street West and a point 35 metres north of Bloor Street West.
2. Enacting a regulation authorizing the operation of parking meter machines from 9:00 a.m. to 6:00 p.m., Monday to Saturday on the west side of Kings Lynn Road between Bloor Street West and a point 35 metres north of Bloor Street West.
3. Enacting a regulation authorizing the operation of parking meter machines from 9:00 a.m. to 4:00 p.m., Monday to Saturday on the east side of Kings Lynn Road between Bloor Street West and a point 35 metres north of Bloor Street West.

4. Enacting a “No Standing, 4:00 p.m. to 9:00 p.m., Monday to Friday” prohibition on the east side of Kings Lynn Road between Bloor Street West and a point 47 metres north of Bloor Street West.

ISSUE BACKGROUND

Transportation Services received a request from Councillor Peter Milczyn, as a result of a meeting with the property owners on Kings Lynn Road, requesting that a “No Standing, 4:00 p.m. to 9:00 p.m., Monday to Friday” prohibition be installed on the east side of Kings Lynn Road between Bloor Street West and the first laneway north of Bloor Street West. This request is a result of parking concerns in the area. A map of the area is Attachment 1.

COMMENTS

Kings Lynn Road is classified as a two-way local road in the residential community to the north of Bloor Street West and east of Prince Edward Drive. Parking meters are located on both sides of Kings Lynn Road between Bloor Street West and the first laneway north of Bloor Street West. Parking in this area is accommodated within lay-bys, located on both sides of the street. Parking is currently prohibited at all times on the west side of the street, north of the parking metres. Parking is also prohibited on the east side of Kings Lynn Road north of the laneway between 10:00 a.m. and 6:00 p.m., Monday to Saturday, with all other times being subject to the unsigned three-hour maximum by-law.

The Kingsway Conservatory of Music is located on the northeast corner of Bloor Street West and King Lynn Road, while Prince Edward Montessori School, operating within the All Saints Kingsway Anglican Church, is located on the northwest corner.

Based on the request from Councillor Peter Milczyn in which the area residents appear to support, it is recommended that a “No Standing, 4:00 p.m. to 9:00 p.m., Monday to Friday” prohibition be installed on the east side of Kings Lynn Road

between Bloor Street West and a point 47 metres north of Bloor Street West. In conjunction with the proposed standing prohibition, it is also recommended that the hours in which the parking meters operate be between the hours of 9:00 a.m. and 4:00 p.m., Monday to Saturday.
