

Toryork Drive - Parking Regulation Amendment

SUMMARY

The purpose of this report is to obtain approval to introduce a 60 minute parking regulation between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday on the north-east side of Toryork Drive between 114 Toryork Drive and 100 Toryork Drive.

This proposed parking regulation amendment will address the short duration parking needs of the adjacent properties.

Since the Toronto Transit Commission (TTC) operates a transit service on Toryork Drive, City Council approval of this report is required.

RECOMMENDATIONS

Transportation Services recommends that City Council approve:

1. Rescinding the “No Parking, 8:00 a.m. to 6:00 p.m. Monday to Friday” prohibition on the north-east side of Toryork Drive, between a point 295 metres west of the westerly limit of Weston Road and the southerly limit of Ormont Drive.
2. Enacting a “60 Minute Permitted Parking Anytime” regulation on the north-east side of Toryork Drive, between Weston Road and a point 295 metres further west.
3. Enacting a “No Parking, 8:00 a.m. to 6:00 p.m. Monday to Friday” prohibition on the north-east side of Toryork Drive, between a point 295 metres west of Weston Road and a point 330 metres further west.

4. Enacting a “60 Minute, 8:00 a.m. to 6:00 p.m., Monday to Friday” parking regulation on the north-east side of Toryork Drive, between a point 625 metres west of Weston Road, and a point 140 metres further west.
5. Enacting a “No Parking, 8:00 a.m. to 6:00 p.m. Monday to Friday” prohibition on the north-east side of Toryork Drive, between a point 765 metres west of Weston Road and Ormont Drive.

ISSUE BACKGROUND

Transportation Services received a request from Councillor Giorgio Mammoliti, on behalf of the Mercedes Dealership at 108 Toryork Drive, requesting the introduction of a 60 minute permitted parking regulation on the north-east side of Toryork Drive, along the frontage of the property of 100, 108 and 114 Toryork Drive. Maps of the area are Attachments 1 and 2.

COMMENTS

Toryork Drive is a 12.1 metre wide, two-lane collector road and consists of mainly commercial and industrial use. There are sidewalks on both sides of Toryork Drive. The speed limit on Toryork Drive is 50 km/h.

Parking is currently prohibited anytime on the south-west side of Toryork Drive between Weston Road and Milvan Drive. Parking is permitted up to periods of 60 minutes on the north-east side from Ormont Drive to Milvan Drive and from Weston Road to a point 295 metres west, and parking is prohibited from 8:00 am to 6:00 pm, Monday to Friday on the north-east side of Toryork Drive from Ormont Drive to a point 295 metres west of Weston Road.

The proposed parking regulation amendment on the north-east side of Toryork Drive between 114 Toryork Drive and 100 Toryork Drive will address the additional short duration parking needs by the Mercedes dealership.

In addition, our review has indicated that although 60 minute permitted parking signs are posted on the north-east side of Toryork Drive from Weston Road to a point 295 metres west, no by-law entry exists to support these regulations. The discrepancy in the posted and by-lawed parking regulations may affect uniform enforcement of the parking regulations by the Toronto Police Services, Parking Enforcement Unit. Creating a by-law for the 60 minute permitted parking the north-east side of Toryork Drive from Weston Road to a point 295 metres west will ensure uniform enforcement of the current parking regulations, by the Toronto Police Services.
