4.1. Saleha Nahdi from Crisis Response Unit to discuss their services and impact of violence and mental health on residents.

Community Crisis Response Program intervenes when a violent incident has occurred, recognizes that a community may be in crisis, responds by working with City, Police Services and Community Partners to obtain timely and accurate crime information, coordinates crisis responses training for community residents, implements a training strategy.

The Crisis Respond Unit work with other City divisions, Police Services and community partners to coordinate joint meetings, engage in joint planning and

debriefing' coordinate follow-up activities and support a community healing process.

Also coordinates crisis response training for City of Toronto staff. Saleha distributed flyers with information about Community Crisis Response Program and Community Resources. (e-Powerpoint file attached - double click to start presentation)

4.2. Guest speaker: Dawne Barbierir, from EGH was unable to attend the meeting. The presentation was deferred until next meeting.

4.3. Toronto Community Housing's Mental Health Framework and it's impact on communities – Linda Coltman.

Linda presented some of the statistics and core strategies. TCHC is a non-profit housing, which provides housing for low income tenants. Despite its significant population of tenants with mental health illness, Toronto Community Housing is not staffed to provide supports to large numbers of tenants with mental health or addiction issues. 20% of streets to home are in TCHC.

The mental health framework was guided by a 12 member advisory committee. The committee included representation from a diverse set of agency stakeholders within the mental health sector. The Framework is supported by 10 recommended strategies – six core strategies and four enabling strategies. The framework has yet to be adopted by TCHC. Linda will continue to provide members with updates. Linda to ask TCHC Social Inclusion staff, Brian Davis to speak at the next LHC meeting. Defer further discussion to March meeting.
