

# **By-law Amendments: Evelyn Wiggins Drive**

## SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with the City policy or by-laws.

To obtain the approval to amend the existing traffic by-laws associated with Jack Evelyn Wiggins Drive and Elia Lane, given the renaming of these roadways as follows:

- Jack Evelyn Wiggins Drive to Evelyn Wiggins Drive;
- Elia Lane to Jack Wiggins Lane; and
- Block 348 on Plan 66M-2439 (public walkway) to Elia Lane

## RECOMMENDATIONS

Transportation Services Division recommends that North York Community Council:

#### FINANCIAL IMPACT

All costs associated with the installation of the parking regulations are included within the Transportation Services Division's 2010 Operating Budget estimates.

### **ISSUE BACKGROUND**

City Council at it's meeting of May 25, 26, & 27, 2009, adopted that City Council authorize that the names of the streets and lanes should be changed as follows:

- 1. Jack Evelyn Wiggins Drive be renamed as "Evelyn Wiggins Drive";
- 2. Elia Lane be renamed a "Jack Wiggins Lane";
- 3. The walkway identified as Block 348 (The Walkway) on Plan 66M-2439 be renamed "Elia Lane".

It should be noted that the City Surveyor has conducted a poll of the property owners and residents affected by the renaming of Jack Evelyn Wiggins Drive, in accordance with the City's Street Naming Policy. The poll has indicated that the majority are in favour of the name change.

## COMMENTS

This Division's review has indicated that "Jack Evelyn Wiggins Drive" operates as a two-way, north/south roadway that connects Murray Ross Parkway and Assiniboine Road and "Elia Lane" is a laneway providing access to the garages of the properties that front onto Block 348 (The Walkway).

In view of Councils Decision to change the street names of these roadways, it has become necessary for the Traffic Operations Section to submit a report to amend the existing traffic by-laws associated with these roadways.

The amendment to the by-laws will ensure that any enforcement can be conducted of the traffic laws on these roadways.
