NAMING the proposed private lanes at 225 to 239 Finch Avenue East as "Hayes Lane" and "Strawflower Mews".

At its meeting to be held in the Council Chamber at the North York Civic Centre, Lower Level, on Tuesday, the 25th day of May, 2010 at 9:45 a.m., the North York Community Council will hear in person or by his or her counsel, agent or solicitor, any person who claims that his or her lands will be prejudicially affected by the proposed by-law and who applies to be heard, with respect to the proposed by-law.

If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it – such as your postal address, telephone number or e-mail address – available to the public, unless you expressly request the City to remove it.

The City videotapes committee and community council meetings. If you make a presentation to a committee or community council, the City will be videotaping you and City staff may make the video tapes available to the public.
