Stopping Prohibitions: Seeley Drive

SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with City policy or by-laws.

To obtain approval to prohibit stopping at any time, for areas adjacent to each walkway entrance to the apartment buildings where a drop curb is present on Seeley Drive.

The stopping prohibitions will address the residents concerns with respect to the difficulty in accessing the buildings.

RECOMMENDATIONS

Transportation Services Division, North York District recommends that North York Community Council:

Financial Impact

All costs associated with the stopping prohibitions on Seeley Drive are included within the Transportation Services Division's 2010 Operating Budget.

ISSUE BACKGROUND

Transportation Services Division, North York District, was requested by Councillor Maria Augimeri on behalf of area residents, to review the feasibility of prohibiting stopping at any time, for areas adjacent to the walkway entrances to the apartment buildings on Seeley Drive.

The residents are concerned that vehicles parked on Seeley Drive block the walkway entrances to the apartment buildings and creates a hazard to pedestrians accessing the apartment buildings.

COMMENTS

Currently, on the west side of Seeley Drive, from December 1 to March 31, parking is prohibited at any time from the 1st day to the 15th day of each month, and 12 hour parking is permitted between the hours of 8:00 p.m. and 8:00 a.m., from the 16th day to the last day of each month. From April 1 to November 30, 12 hour parking is permitted from 8:00 p.m. to 8:00 a.m.

On the east side of Seeley Drive, from December 1 to March 31, 12 hour parking is permitted between the hours of 8:00 p.m. and 8:00 a.m., from the 1st day to 15th day, and parking is prohibited at any time from 16th day to the last day. From April 1 to November 30, parking is prohibited at any time.

This division's review has confirmed that the vehicles parked on the street creates an obstruction for pedestrians accessing the apartment buildings. The installation of stopping prohibitions on Seeley Drive will improve accessibility to the residential walkways.

Councillor Maria Augimeri supports the recommendations of this staff report.
