Introduction of Overnight On Street Permit Parking Hours: Elm Road

SUMMARY

This staff report is about a matter over which North York Community Council has delegated authority to make a final decision provided that it is not amended so that it varies with City policy or by-laws.

To request an approval from North York Community Council to introduce overnight on street permit parking on both sides of Elm Road, between Fairlawn Avenue and Brookdale Avenue, on a street name basis, from 12:01 a.m. to 7:00 a.m., 7 days a week.

RECOMMENDATIONS

Transportation Services Division, North York District recommends that North York Community Council:

1. Amend Schedule A of Municipal Code 925 to incorporate Elm Road, between Fairlawn Avenue and Brookdale Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week.

Financial Impact

All costs associated with the installation of the revised permit parking signage are included within the Transportation Services Division's 2010 Operating Budget estimates.

ISSUE BACKGROUND

A request was received from Councillor Karen Stintz, on behalf of area residents, for the introduction of overnight on street permit parking on Elm Road, between Fairlawn Avenue and Brookdale Avenue, on a street name basis, from 12:01 a.m. to 7:00 a.m., 7 days a week.

COMMENTS

Elm Road, between Fairlawn Avenue and Brookdale Avenue, is a local street operating in a two-way north/southbound direction, on a pavement width of 8.5 metres. No TTC service operates on Elm Road. Parking is allowed for a maximum period of 3 hours on both sides of the street.

Under the provisions of the Municipal Code, Chapter 925, Permit Parking, we are required to conduct a poll of the residents to determine if there is support to introduce permit parking.

Ballots were mailed on October 22, 2009, with the last day for filing a response being November 20, 2009. The results of the poll are as follows:

A field survey has determined that there are total of 17 potential on-street parking spaces available on Elm Road, between Fairlawn Avenue and Brookdale Avenue.

The majority of area residents returned their ballots in favour of the introduction of overnight on-street permit parking on Elm Road, between Fairlawn Avenue and Brookdale Avenue to accommodate their long term need for on-street parking.

Transportation Services Division recommends the introduction of permit parking on Elm Road to accommodate the long term parking needs of the area residents.

Councillor Stintz has been advised of the recommendations of this report.
