Proposed Parking/Stopping Regulation Amendments on Both Sides of East Avenue in the Vicinity of William G. Davis Junior Public School

SUMMARY

This staff report is about a matter for which the Community Council does not have delegated authority from City Council to make a final decision.

This report on East Avenue details the minor on-street stopping and parking regulation changes required to enhance both traffic safety and flow in proximity to William G. Davis Junior Public School. Stricter no stopping regulations on East Avenue to help ensure clear sight lines for approaching motorists and pedestrians are recommended within this report.

Council's approval of the stopping and parking regulations will enhance traffic safety at these locations and allow enforcement by the Toronto Police Service.

RECOMMENDATIONS

Transportation Services, Scarborough District, recommends that Scarborough Community Council recommend that City Council:

- 1. Rescind the parking and stopping regulations, as identified in Appendix 1 of this report.
- 2. Enact the stopping and no parking regulations, as identified in Appendix 2 of this report.

3. Amend the appropriate by-law(s) accordingly.

Financial Impact

The financial cost of installing these parking regulation signs is approximately \$1,000.00. Funding for the signs is available in the Transportation Services 2010 Operating Budget, within Cost Centre TP0397.

ISSUE BACKGROUND

This report is the follow-up to a motion raised by Councillor Ron Moeser in the March 2009 Scarborough Community Council. Councillor Ron Moeser, on behalf of school personnel of William G. Davis Junior Public School, inquired about changes to parking/stopping regulations on both side of East Avenue and Maberley Crescent in the vicinity of William G. Davis Junior Public School. Transportation Services staff reviewed the current parking conditions on this roadway and conducted a school zone review during morning and afternoon periods.

Staff investigations verified the concerns that as vehicles parked on both sides of East Avenue during the time of student pick-up and drop-off time, parked vehicles created a potentially dangerous situation for motorists and pedestrians.

COMMENTS

Several characteristics describing the subject portion of East Avenue include:

- The Toronto Transit Commission operates a revenue service along this portion of East Avenue.
- The land use on East Avenue is comprised of single family dwellings.
- East Avenue is a two-lane collector road with a posted speed limit of 40 kilometres per hour and a traffic volume of approximately 3900 vehicles per day with an 85th percentile speed of approximately 55 km/h.
- East Avenue has a pavement width of approximately 9.8 metres.
- Currently parking is regulated by some limited school zone "No Stopping, Anytime" regulation in the vicinity of William G. Davis Junior Public School. The unposted three-hour parking limit bylaw controls parking along Maberley Crescent at East Avenue.
- When vehicles are parked on both sides of East Avenue in the vicinity of the school, two-way traffic cannot be safely maintained.

It is recommended that Transportation Services install "No Stopping Anytime" signs along the west side of East Avenue from Golders Green Avenue to opposite Baronial Court. Similarly, these same "No Stopping Anytime" regulations should be installed along the east side of East Avenue from just south of Golders Green Avenue to Baronial Court.

In summary, these stopping regulations will make this school zone on East Avenue and Maberley Crescent consistent with the traffic environment of many school areas, will reduce pedestrian mid-block crossings and will help to maintain sightlines for all road users at this location.

Staff anticipate that the proposed parking regulations will enhance safety for pedestrians and motorists.
