Notice was given and a Public Hearing was held on Wednesday, January 27, 2010, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To maintain six street yard parking spaces at the front of the existing industrial building.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

To permit the existing six parking spaces in the front yard, whereas the Zoning By-law only permits parking spaces in side yards, rear yards or enclosed within buildings, except that five parking spaces are permitted in the front yards or flankage yards for the first 15 m of front wall, plus two parking spaces for each 15 m of front wall thereafter.
