THE CONSENT REQUESTED:

The applicant is seeking consent to sever the subject site into two residential lots, identified as Parts 1 and 2 on the attached lot division plan. Part 1(Retained Lot) will have a frontage of 7.62 m, a depth of 32.13 m and an area of 244.1 square metres; Part 2 (Conveyed Lot) will have a frontage of 7.62 m, a depth of 32.13 m and an area of 244.6 square metres. Each lot is to be developed with a two-storey single family dwelling. The existing dwelling is to be demolished.
